QUESTIONS AND ANSWERS

Pitanja i odgovori se odnose na zahtev za ponudu UNOPS -SFRS-2014-S-037 - Redizajn i ponovna izrada internet-stranice Kancelarije za pomoć i obnovu poplavljenih područja.

1. P: Da li je neophodno da se novi/redizajnirani sajt nalazi na Windows serveru?

O: Ne, nije neophodno da to bude Windows server.

2. P: U delu "Additional requirements", tačka 5, navodite da Open source rešenja nisu prihvatljiva. Šta podrazumevate pod Open source rešenjima, posebno jer u Appendix B - Technical requirements, kao implementiranu tehnologiju navodite PHP - koji je Open source?

O: Restriktivna lista resenja ponudjena od nadležnih za IT sistem Vlade Srbije ne dopustaju koriscenje open source resenja. Medutim, saglasnoscu da se novi (redizajnirani sajt) postavi na nekom drugom (javnom) serveru ukida tu restrikciju, tako da su open source resenja prihvatljiva.

3. P: Da li bi bilo dozvoljeno koristiti Drupal kao aplikativno rešenje na Windows platformi, pomoću PHP koda?

O: Nema posebnih ogranicenja u koriscenju aplikativnih resenja tog ranga - sve dok ne uticu na funkcionalnost i efikasnost odrzavanja/osvezavanja sadrzaja.

4. P: Osvrćemo se na Appendix A, Section 5, tačka 2. Content management: da li unos/izmene sadržaja sajta nije neophodno raditi isključivo kroz Front end - sve dok zadovoljavaju zahteve koje ste naveli i WYSIWYG princip?

O: Da, to podrazumeva da se izmene i unos podataka rade preko Front-end interfejsa, bez instalacije bilo kakvih posebnih dodatnih softverskih alata.

Reference is made to RFQ No. UNOPS -SFRS-2014-S-037 - Redesign and Redevelopment of FAAAR Office Website.

1. Q: Is it necessary for the new/redesigned website to be on Windows server?

A: No, it does not have to be a Windows server.

2. Q: In the part “Additional requirements”, point 5, you declare that Open source solutions are not acceptable. What do you mean by “Open Source solutions”, especially if in Appendix B - Technical requirements, as implementing technology you require PHP – which is an Open source?

A: The restrictive list of solutions, offered by the Serbian Government IT experts, does not allow the use of open source solutions. However, given the authorization that allows the new (redesigned) website to be put on another (public) server, that restriction is cancelled, therefore open source solutions are acceptable.

3. Q: Would it be allowed to use Drupal as application solution on Windows platform, using PHP code?

A: There are no special restrictions in use of application solutions, as long as they don't have any influence on functionality and efficiency of content editing/updating .

4. Q: With reference to Appendix A, Section 5, point 2: the website content editing/updating does not need to be done exclusively using Front end – as long as the solution meets all of your requirements, as well as WYSIWIG principle?

A: That means that data editing/updating are done using Front-end interface, without installing any other special software tool.
