4. Paragraph 38 Post-qualification of the Bidder (Line 38.4) of the ITB Section I is changed as follows:

After determining the lowest priced substantially compliant offer in accordance with Instructions to Bidders Sub-Clause 37.1, UNOPS shall carry out the post-qualification of the Bidder in accordance with Instructions to Bidders Clause 38, using only the requirements specified. Requirements not included in the text below shall not be used in the evaluation of the Bidder's qualifications.

(a) Financial Capability

The Bidder shall provide the following documentary evidence:

- **Document from Business Registers Agency (Izvod iz APR)**
- **Tax administration receipt that the company paid all local and national taxes (Potvrda o izmirenim porezima i drugim javnim dadzbinama)**
- **Financial statements and solvency reports for last 3 years to be provided (Izvestaj o bonitetu ili bilansi stanja i uspeha za zadnjih 3 godina).**

(b) Experience and Technical Capacity

The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):

- **Bidder should be in continuous business of supplying the specific goods as specified in the 'Schedule of requirement' during the last 3 (three) year**
